### 1. OPENING OF THE SESSION

The eighty-ninth regular session of the Council will be opened by its Chairperson, Ms. Ana Tofftén (Sweden).

#### 2. ADOPTION OF AGENDA

The Council will consider the draft agenda contained in this document as a basis for adopting its agenda.

# 3. Approval of the report of the 88<sup>th</sup> regular session of the International Cocoa Council

The Council will be asked to approve the report of its 88<sup>th</sup> regular session, contained in document ICC/REP/88

#### 4. REPORT ON CREDENTIALS

After consultations with the Chairperson, the Secretariat will report on the receipt of credentials for the current session of the Council. (This report will be circulated as document ICC/89/2).

#### 5. Membership of the International Cocoa Organization

The Secretariat will report on the status of membership of the International Cocoa Organization, with reference to document ICC/89/3.

As agreed at its 88<sup>th</sup> regular session in September 2013, the Council will consider the possible duration of a "gentlemen's agreement" related to the payment of contributions to the Organization's Administrative Budget.
